The Armed Forces Officers in the rank of Brigadier or equivalent in the department of Judge Advocate General in Army/Navy/Air Force, due to retire or who are to be transferred to reserve within a period of one year, shall also be considered. (Re-employment up to the age of superannuation with reference to the post in the organisation.)
